We hope you're all doing great! During our spring meeting, I had the chance to talk with some of you about two possible multistate projects being proposed by researchers from Michigan State University. Short (and preliminary) plans for the projects are attached, and the titles appear below:

1. State of the Harvest: toward data standardization and synthesis to quantify the value of wild harvests to human society in the United States
2. Understanding and evaluating the risks of PFAS contamination to agricultural systems and development of solutions.

At this time, we're asking for one letter of support for each project written by an experiment station director (MSU will be providing the second letter for both projects). With these letters written, it will allow the PIs to formally begin developing the team along with the project proposal, due in September.
