A long-time collaborator from the University of Wisconsin and I are members of the NCCC31 - Ecophysiology Aspects of Forage Management, which recently met in North Dakota. There, he and I discussed starting a new multi-state project focused on perennial grains. We are very confident that we could recruit a strong team of researchers from across the US to participate.

We proposed the idea and received support for it from Chris Hamilton, the Assistant Director of the NCRA State Ag Experiment Station. Chris said that the next step would be to get support from two Deans. The Dean of CALs at UW-Wisconsin has endorsed the idea. Ruth Sanborn said that you would be the Dean in CFANS to contact regarding this.
