## **NRSP1 Mid Term Review**

**COMMENTS:** *NRSP1 has two key objectives, with the second being: “Effectively document and communicate the impacts of multistate research, enhance the utility of MRF Impacts materials, and improve the capacity of Hatch Multistate project participants and others to report their impacts.” This objective plays a critical role in ensuring that science-based outcomes inform public policy discussions.*

*Data collection of the impact of outreach efforts by the MRF Program Coordinator/Writer demonstrates significant success in disseminating MRF outcomes, reaching thousands through multiple communication channels, including newsletters and social media. Additionally, the annual training provided to diverse audiences equips participants with the skills and knowledge necessary to further amplify these messages, expanding the reach and impact of multistate research.*

### **IMPLEMENTATION OF THE NRSP**

#### **Management and Business Plan**

Is the NRSP making progress on the implementation, and management of the business plan and meeting funding expectations?

**COMMENTS:** *NRSP1 continues to serve as a vital internal management system, supporting a diverse stakeholder base in achieving Objective 1: “Maintain and enhance the effectiveness, functionality, and utilization of NIMSS.” Throughout this reporting period, the NRSP1 management team has consistently improved NIMSS, incorporating enhancements based on user feedback from the Agricultural Experiment Station (AES) system.*

*In early 2024, the NRSP1 management team (RSAs) collaborated with Clemson ITT to beta test and then launch an upgraded NIMSS system. This NIMSS 2.0 release includes an updated database framework, data query systems, faster search and information display functions, and more comprehensive system testing, all of which make implementing regular software updates easier and reduce potential security vulnerabilities. This suite of upgrades further streamlines multistate project management and reporting. For those accessing NIMSS on their mobile devices, pages and function display in a more user-friendly fashion than previously and allow for quick and effective access on the go; no more waiting to return to the office to add new users, authorize meetings, upload files, etc. Users can accomplish just about all tasks on the mobile site as they would on the desktop version.*

*Stakeholders widely recognize the effective management of NIMSS, particularly the team’s rapid response to requests and prompt implementation of user-driven improvements. Clemson ITT remains an exceptional partner in overseeing NIMSS, ensuring it remains a responsive, user-friendly platform for organizing, storing, and sharing critical information related to multistate research project review, reporting, and impact assessment.*

*In 2024, NRSP1 updated the Rules of Operation to improve and streamline the management of NRSP1.*

*Financially, NRSP1 continues to meet funding expectations. A necessary increase in support for the MRF Program Coordinator/Writer was successfully implemented, and the 2025 budget allocation of \$253,395 came in slightly below the projected \$259,754, demonstrating responsible budget management.*

#### **Progress toward objectives and projected outcomes:**

**COMMENTS:** *As previously stated, NRSP1 has made significant progress toward its two primary objectives: managing and enhancing NIMSS and expanding the visibility of multistate research impacts through diverse communication platforms. These efforts directly benefit the Agricultural Experiment Station (AES) system by improving efficiency, accessibility, and outreach.*

*Key activities—including the testing and rollout of a new NIMSS system, strategic impact communication, continuous optimization of NRSP1 management, and proactive integration of user-driven enhancements—have strengthened the effectiveness of NIMSS as a critical research management, review, and reporting tool. By aligning system improvements with stakeholder needs, NRSP1 has enhanced both the functionality of NIMSS and the reporting of multistate research outcomes.*

#### **Integration:**

**COMMENTS:** *NRSP1 does an exceptional job of integrating and collaborating with key stakeholders (e.g., NIFA, regional association leadership, Clemson IT, and communications) in the management and oversight of NIMSS and multistate research impacts communications as mentioned in other sections of this review. Good examples during the reporting period include working closely with regional stakeholders and Clemson IT in upgrading and testing NIMSS for enhanced functionality and security.*

- **COMMENTS** for above three bullets:

*NRSP1 leadership maintains a strong commitment to responsiveness and stakeholder engagement, ensuring that the management of NIMSS and the communication of multistate research impacts align with the needs of key audiences. The primary stakeholders of NRSP1 include the Agricultural Experiment Station (AES) system and NIFA, with additional stakeholders encompassing a broad network of individuals who receive multistate research impact communications through the efforts of the MRF Program Coordinator/Writer.*

*The active participation of regional association leadership, NIMSS users, MRF Program Coordinator/Writer, and NIFA in NRSP1 remain crucial to the system's success. Quarterly NRSP1 meetings serve as a vital forum for discussing NIMSS system improvements, addressing emerging issues, and identifying opportunities to enhance system effectiveness. Additionally, ongoing stakeholder engagement and feedback throughout the year informs refinements to NIMSS functionality. The four NIMSS Regional System Administrators (RSAs) play a central role as primary points of contact, providing training and support to university administrators, program managers, investigators, business officers, and station staff. RSAs facilitate the integration of user feedback, ensuring continuous improvements that enhance system usability and efficiency. The MRF Program Coordinator/Writer also engages directly with the greater Land-grant system on national level committees including the [APLU BAA Communications and Marketing Committee](#), National Impacts Database communications team, and during national level professional meetings (e.g., Association of Communication Excellence, National Extension and Research Officers Conference).*

*Furthermore, regularly monitored metrics, reviewed during NRSP1 quarterly meetings, highlight the significant reach and impact of multistate research communications. The oversight of these outreach data by the MRF Program Coordinator/Writer provides clear evidence of broad dissemination across multiple communication platforms, reinforcing NRSP1's essential role in amplifying the visibility and value of multistate research.*
