W5001 Annual Report – Year Three (2023 – 2024) Accomplishments

PRESENTATIONS

In the second year of W5001, over 60 in-person and virtual presentations were made to fellow researchers at annual meetings of professional associations, university seminars, and other research conferences, including the Rural Sociological Society, the American Sociological Association, the Population Association of America, the American Association of Geographers, the American Public Health Association, the Community Development Society, Association for Policy Analysis and Management, the National Council on Family Relations, and the Gerontological Society of America, among a number of other smaller regional conferences and meetings.

POLICY OUTREACH

Members consulted at the highest levels of federal policy as members of, or consultants for: the Office of Management and Budget's Interagency Committee on Metropolitan and Micropolitan Standards; Office of Management and Budget's Interagency Working Group on Race and Ethnicity; the Federal Committee on Statistical Policy Directive No. 15 (FC SPD 15), which is charged with government-wide implementation of new race/ethnic data collection standards (SPD 15) and reviewing government collection and distribution of race/ethnic data; the U.S. Government Accountability Office; the United States Forest Service Social Science research group; and the United States Global Change Research Program.

Members conducted briefings, workshops and consultations to state and federal policymakers, extension officials, community organizations, and other stakeholder groups, including: National Academies of Science, Engineering, and Medicine; Utah State Governor and Legislature; Washington State Legislature; the Florida Department of Elder Affairs; City of Madison, WI Common Council; Copper Shores Community Health Foundation; Team Peninsula of MI; New Hampshire State Legislature; American Enterprise Institute; Brookings Institute; Wisconsin Farm Bureau Board of Directors; Iowa Farm Bureau Agriculture Leaders Summit; South Dakota Farm Bureau; Living Water Cooperative of the Upper Midwest; Oregon Parenting Education Collaborative; Montana Department of Public Health and Human Services; Oregon Department of Human Services; Kansas Geological Survey; Masonic Cancer Alliance; and extension professionals and stakeholders across Iowa, Pennsylvania, and Utah, among others. In addition to in-person or

virtual briefings, members also prepared and published 15 policy briefs and reports.

Impacts

Over the course of the study year, members of W5001 impacted science and society in numerous ways. We report our impacts in-line with our study objectives:

Objective 1: Describe recent U.S. rural population change and the components of these changes, and investigate the roles of recent population health, environmental, and policy shocks and stressors in driving these changes

- In response to a Congressional request, the group helped develop an innovative, science-based measure of ruggedness to improve rural policy and increase more equitable access to rural resources and opportunities. The Federal Office of Rural Health Policy (FORHP) has already modified its eligibility criteria for rural health grants to include terrain factors, specifically using this new Road Ruggedness Scale (RRS). The change better identifies areas with difficult access to healthcare due to rugged terrain, expanding eligibility for FORHP grants.
- Members of our group informed Extension specialists on the drivers and implications of population change in rural communities. We brought together over 100 specialists from multiple regions. The knowledge generated from this convening is being used to inform their local and regional programming in critical areas of community and economic development, natural resources, and health.
- Insights from the RPRN Listening Sessions with more than 100 rural development stakeholders from 23 states were used to inform Extension professionals in developing a better understanding of rural population characteristics and trends and to help them request the types of research they need to help inform their work for future. This included dissemination of a report and a webinar with 48 participants from across the country.
- At the request of the American Farm Bureau Federation (AFBF), a W5001 member presented on rural population trends to 12 state directors from the Midwest. The W5001 member assembled the presentation, facilitated a discussion, and produced 12 state demographic profiles. The information and discussion helped inform changes to AFBF operations, outreach, and collaboration across states. This resulted in additional presentations and facilitated discussion to four other state farm bureaus.

- Literature from members of this group, coupled with data from the Net-Migration for U.S. Counties site, was used to inform strategic planning in Mississippi for the Land-Grant University's role in helping to address community vitality in rural places experiencing population loss, working with industry and government partners.
- Dr. Ken Johnson's analysis of recent rural demographic trends is contributing to rural prosperity and economic development by providing important information to planners and policymakers and is being used by a National Science Foundation K-12 Education Task Force, the Russell Sage Foundation, and the NH State Legislature.
- Members of the RPRN network generated new classifications of rurality, along a rural-urban continuum (Rural-Urban Continuum Codes, Rural-Urban Commuting Areas, and Frontier and Remote Area codes), for counties, census tracts, and zip codes that are being used by federal agencies for determining eligibility for various programs including in Health and Human Services, the Small Business Administration, Veteran's Administration, the US Department of Agriculture, and the Florida Department of Elder Affairs.
- Dr. Matt Brooks and Shelley Clark wrote an Op-Ed at the Washington Post on changing rural families and misconceptions the general public may have on them.

Objective 2: Describe shifts in rural economic well-being (i.e., poverty, livelihood strategies, income, housing, infrastructure) in the context of recent population health, environmental, and policy shocks and stressors and identify linkages between economic wellbeing and population dynamics, policies, and institutional responses.

- Published reports from RPRN utilized by elected state officials in PA to inform their work as part of the Rural Population Revitalization Commission.
- Drs. Shannon Monnat and Tim Slack were invited to present their research on rural population health trends and challenges to the Aspen Health Strategy Group in 2025. Based on the discussions in that meeting, former Senate Majority Leader Bill Frist wrote a 4-part series on improving rural health, published in *Forbes* (https://www.forbes.com/sites/billfrist/2025/07/15/rural-health-resilience-a-four-part-series-on-healing-the-other-america/). In addition, Frist and former Kansas Governor and HHS Secretary Kathleen Sebelius wrote a commentary

for U.S. News and World Report about how proposed policy changes could aversely affect rural health and health care (https://www.usnews.com/opinion/articles/2025-07-01/gop-big-beautiful-bill-pass-house-senate-medicaid). These efforts helped to inform policymakers, reporters, and the general public about rural health and health care challenges and have potential to influence future policy decisions.

- Place-based research conducted in rural communities in Utah and Washington state demonstrated that community members in high natural amenity places are concerned about population growth, housing affordability, and overtourism. We published research on these case studies, specifically relating to increases in tourism and amenity driven in-migration in the years following the COVID-19 pandemic. This research led to an invitation to participate in a Washington State Legislature funded project entitled "Investigating Housing Market Conditions in Tourism-Dependent Municipalities." This project led to a report written for the Washington State Legislature advocating for rural community housing needs, as well as presentations and engagement with city and county governments throughout Washington.
- Research on short-term rentals, tourist lodging, and housing in northern
 Utah received significant press coverage in high readership newspapers and
 statewide radio stations. This coverage led to increased conversations about
 the need for robust short-term rental regulations and housing policy,
 particularly in high amenity rural communities.
- Research from the shrink smart project, on how declining towns have maintained or grew quality of life, helped a community of 2,000 people in west central lowa successfully obtain a \$750,000 USDA Rural Development grant to remodel a shuttered middle-school building into senior housing. The community used W5001 research in the grant proposal; and a W5001 member conducted several community facilitations to refine the project and help write the proposal.
- Research on broadband access and utilization in rural areas was used to inform Extension programming for train-the-trainer programs to advance digital skills in rural communities.
- Demographic research on migration, population aging, and mortality was used to help expand knowledge of Extension professionals and those

working with nonprofit organizations to help families dealing with heirs' property and difficult family land transfers. This included opportunities to offer more Extension workshops in places with high levels of net outmigration.

- Dr. Lori Hunter published a piece in the <u>Conversation</u> on the vulnerability of older, rural Americans to extreme events which received nearly 4,400 "reads" and was reprinted in over 35 local newspapers. Brant published a piece in the Conversation on housing insecurity in rural Appalachia amid extreme weather events which received over 10,000 reads and was reprinted in over 10 other outlets.
- Research on the effects of Medicaid expansion on rural mortality was used in an evidentiary hearing in the Montana State legislature.
- Continued to develop Utah's first longitudinal, statewide, representative survey of residents, including an oversample of rural residents, to understand their views on longstanding and emerging environmental issues. Publicly available briefs and reports have been downloaded over 4,000 times.

Objective 3: Investigate how recent shocks and stressors affect trends in rural population health, disabilities, and health disparities across the lifespan and how communities and institutions respond to and adapt to these challenges

- Research on aging-related healthcare changes during periods of upheaval with a focus on perception of societal shocks as threats in rural and urban communities across the state of Wisconsin, using the example of advance care planning during the pandemic, was presented to legislators at the Wisconsin State Capitol.
- Data from the National Wellbeing Survey, which was created by members of this group and includes an oversample of residents from nonmetropolitan counties, were downloaded over 6,000 times in the past year. This data resource is making it possible for the broader research community, including those outside of W5001, to conduct research that can generate new knowledge about rural health, employment, and economic wellbeing in the United States.
- Dr. Katherine Curtis and collaborators generated new research on wildfires and migration in the United States. Our study was selected by the NICHD

Population Dynamics Research Branch for an online feature authored by an NICHD Senior Policy Advisor for broad public access and targeted dissemination to national policymakers. This research is enhancing public knowledge about the migratory consequences of wildfires.

• Drs. Leif Jensen and Shannon Monnat were invited to offer presentations on rural health as two of four featured presentations for a workshop on Health in Rural America: Challenges and Opportunities organized by the NIH Health Disparities Interest Group (HDIG). The workshop reaches health researchers in NIH and beyond.
