5. Update on NIFA (formerly CSREES) by Jane Schuchardt, National Program Leader

Effective October 1, 2009, the Cooperative State Research, Education, and Extension Service, USDA, became the National Institute of Food and Agriculture (NIFA). Created by the 2008 Farm Bill, NIFA is designed to raise the stature of agricultural science (and related fields including consumer and family economics), provide innovative solutions to global problems, work with other federal science agencies, and contribute to science policy decision-making. Under the direction of Secretary of Agriculture Tom Vilsack, USDA Chief Scientist Rajiv Shah, M.D., will work with

Roger Beachy, Ph.D., NIFA Director, to lead programs of focus, scale, and impact related to global food security and hunger, climate change, sustainable energy, childhood obesity, and food safety.

NIFA was officially launched on October 8th at an event at the National Press Club, Washington, DC www.visualwebcaster.com/NIFA-Rollout. Components of NIFA are the Institute of Food Production and Sustainability; the Institute of Bioenergy, Climate, and Environment; the Institute of Food Safety and Nutrition; the Institute of Youth and Community Development, and the Center for International Programs. All major authorities of NIFA as the federal partner in the Land-grant University, Agriculture Experiment Station and Cooperative Extension Systems remain the same. Emphasis will be placed on functional integration of research, education and extension. NCCC052 researchers are encouraged to contribute the consumer perspective on major issues outlined by NIFA.

6. Review of Ongoing Work by NCCC052

Research Summaries on eXtension Personal Finance Website

Thirty-seven research summaries were prepared by authors of recent journal articles. Authors were generally receptive to requests to prepare summaries for laypersons. The following were assigned at the 2008 meeting to follow the contents of the journals and contact authors: Financial Services Review – Fran Lawrence; Journal of Financial Planning - Liz Gorham; Journal of Consumer Education - Urvi Neelakantan; Journal of Consumer Affairs - Cindy Fletcher; and Journal of Family and Economic Issues – Craig Gundersen. Michael Gutter will monitor the Journal of Financial Counseling and Planning Education; others are welcome to identify a journal to monitor and request summaries. This is an ongoing project; the plan is to continue monitoring these journals and requesting summaries from authors so that more summaries will be posted by next year's NCCC052 meetings. This project continues to be headed by Sharon Seiling at Ohio State University (sseiling@hec.ohio-state.edu).

Policy Briefs

Gundersen reported that eight family economics policy briefs have been prepared and posted on a University of Illinois website; however he indicated that Illinois may no longer be the best place to host this webpage. The objective is to expand policy makers' access to applied family economics research that is policy relevant. The goal was to prepare one brief for every two faculty members included on a state's station report. There was discussion of the purpose, intended audience and alternative posting sites. Cindy Jasper will explore posting the existing briefs on NIMMS and will report back to Gundersen, Huddleston-Casas, and Gutter by November 1. There was discussion of basing briefs on technical reports as well as published journal articles, but there was no consensus to change current criteria.

2. Plans for Future Work by NCCC052

Committee Objectives

Gundersen reviewed the objectives that were posted on the NIMMS website at the time of the meeting. These can be obtained by contacting Craig Gundersen (cggunder@illinois.edu).

Discussion ensued about proposed changes. There was a suggestion to combine Objectives #4 and #5. Schuchardt suggested adding an objective to enhance professional development opportunities for graduate students and new professionals and to grow new leadership in family economics. There is need to enhance the quality of graduate students' research and identify new funding sources. Questions were raised about deleting Objectives #2 and #3, noting that a goal of the committee is to increase rigor and relevance. Another goal is to set direction for research in the field of family economics. Gundersen agreed to draft revisions, pass these along to Cathey Huddleston-Casas for her review. A renewal application for NCCC052 is due September 10, 2010.

Future Activities

There was a suggestion of submitting a panel at a professional meeting to publicize the work of NCCC052. Possible meetings include ACCI and APPAM. No specific decision or plan was devised.

Registration Fee

The registration fee, to be paid to University of Florida, was set at \$63.68.

Location of Meeting Next Year

The 2010 NCCC052 annual meeting site was determined. Cathy Huddleston-Casas has graciously agreed to host the meeting in Omaha, Nebraska and to serve as Local Arrangements Chair.
