NRSP-8 Business Meeting Date January 13, 2013

1. Call to order by Tom Porter (roughly 5:15), with Milt Thomas serving as the secretary.

2. Update on NRSP8 renewal – Tom Porter

In brief, Tom reported that the writing committee started working in early spring of 2012 and a draft of the proposal was submitted to the directors of the Agricultural Experiment Stations that summer. A response was quickly provided then the writing committee, species coordinators, and the leadership of NRSP-8 revised and resubmitted the proposal last week (i.e., late December 2012). A response from the Directors of the Agricultural Experiment Stations is expected by June of 2013. The new project should be implemented in September of 2013. Also, accomplishments reports were assembled by each species coordinator and NRSP-8 leadership and submitted the last week of December 2012.

3. Livestock ENCODE project –Alan Archibald and Martien Groenen

The Encyclopedia of DNA Elements (ENCODE) Consortium is an international collaboration of research groups funded by the National Human Genome Research Institute (NHGRI; http://genome.ucsc.edu/ENCODE/). The initial goal of ENCODE was to build a comprehensive parts list of functional elements in the human genome, including elements that act at the protein and RNA levels, and regulatory elements that control cells and circumstances in which a gene is active. Alan Archibald presented an overview of the ENCODE project as it relates to livestock animals. He posed questions to the group. Specifically, which animals and tissues should be included in this project and how do we pool our resources to build a livestock version of ENCODE? He also asked the NRSP-8 group for ideas.

<u>Action item(s):</u> Joan Lunney moved that NRSP-8 assist the concept of further development of ENCODE for livestock animals (i.e., "assist the concept" was defined as participation). Ernie Bailey amended the motion to say that Alan Archibald be the contact for those wanting to participate. Second was obtained for both actions (primary motion and the amendment) and the motion passed unanimously.

4. HUGO Gene Nomenclature Committee (HGNC) – Elspeth Bruford

In brief, Elspeth reported that the HUGO Gene Nomenclature Committee (HGNC) has assigned unique gene symbols and names to over 33,500 human loci, of which around 19,000 are protein coding. Specifically, http://www.genenames.org/ is a curated online repository of HGNC-approved gene nomenclature and associated resources including links to genomic, proteomic and phenotypic information, as well as dedicated gene family pages. Elspeth also reported that ISAG voted that gene names and symbols from animals be synonymous with those already established for humans, which would establish homologous and orthologous relationships across species. 5. Coordinator Reports

Notable highlights: Each species group continues with sequence and SNP-Chip efforts. These tools are at various stages of development depending on when the projects were initiated and funding was obtained. After ~20 years of service, Max Rothschild will stepdown as the swine coordinator in 2013. A new swine coordinator will need to be obtained and approved. The NRSP-8 recognized and thanked Max for his remarkably dedicated effort. Jim Reecy announced that funding will expire in the next 6 months for the data entry technician of tools such as AnimalQTLdb. He informed that he was actively pursuing funding for the position. Jim wanted the group to know that if he is not successful in his effort to accrue funding, that the services may subside or a new procedure for data entry will have to be developed. He encouraged the group to consider the issue and would gladly entertain ideas or assistance.

6. Administrator reports

a. Eric Young

Eric stated that he represented the accumulation of the geographical regions of the Agricultural Experiment Stations. Regarding the new NRSP-8 project, it will be assigned a 5 year budget. A mid-point review is scheduled for year 3. This review will be dependent on the success documented in the annual reports.

b. Lakshmi Matukumalli

Because of time constraints, Lakshmi gave a brief announcement after the meeting. He said he was helping to develop an integrated working group among agencies such as USDA-AFRI, NSF, and NIH. The goal of the activity is to pool funding resources, etc. He stated that he would be soliciting feedback from NRSP-8 leadership and species coordinators.
