## Minutes of the NC-1003 Business Meeting

## **Participants and Meeting Information**

The 2002 meeting featured a workshop titled *Future Public Research Opportunities and Directions*, held from March 14-16. Please see attached program and list of participants. The workshop, held in conjunction with the annual business meeting, featured several invited speakers. These included:

- Dr. Manuel Lantin, Science Advisor, CGIAR Secretariat, World Bank, Washington, DC who discussed future opportunities and directions in agricultural research.

REE Administrators Susan Offutt (ERS), Ed Knipling (ARS, acting), Colien Hefferan (CSREES), and Ron Bosecker (NASS) participated in a panel discussion on opportunities for agricultural research.

NC-1003 members Wallace Huffman, John Miranowski, David Zilberman and Fred Buttel (moderator) also participated in a panel discussion on the role of social scientists on NAS-NRC. The moderator and panelists all recently served on NAS-NRC committees.

There were also 11 research paper presentations on topics including (a) valuing public goods (and bads) in productivity and economic growth, (b) efficient allocation of research resources, (c) intellectual property and information and (d) impacts of agricultural research on technology adopters and other stakeholders. Over 40 participants attended from 15 universities, USDA agencies, and other research organizations.

## **Business Meeting**

The business meeting was held from 9:30 - 12:00 p.m. on March 16. Wallace Huffman, Chair of NC-1003 called the meeting to order.

## Report by NC-1003 Chair

Wallace Huffman (Iowa State) introduced Loren Tauer (Cornell) as a new official member of NC-1003 and Jeremy Foltz (Connecticut) who is considering joining NC-1003. Wally noted that the NC-1003 project (formerly NC-208) was renewed following last year's review.

He then raised the issue of whether papers from this year's workshop could be published in some outlet such as a proceeding. This was followed by a general discussion of ways to post materials on the NC-1003 website and ways to create links between the NC-1003 and other websites. Some asked how easy it was to find the NC-1003 website (maintained at the U. of Arizona). George Frisvold noted that if you query "NC-1003" using the Google search engine, the NC-1003 site is the first site to come up. David Zilberman suggested that paper presenters have their Microsoft Powerpoint presentations posted on the website. Frisvold noted that staff would be available to update the website this summer. Frisvold also noted that quite a number of NC-1003 members had books on agricultural research either just coming out or forthcoming in the near future. He volunteered to create a "books link" section to the website to help advertise these publications.

Wally then introduced Dr. Jim Venette (North Dakota State) as the interim Administrative Advisor for NC-1003.

## **Report of Administrative Advisor**

- Dr. Venette complemented the group on the workshop, noting that there was plenty of room for active discussion between participants.
- The NIMS system (National Information Management and Support System) has been activated. The NIMS system is a web-based application that will allow participants of Multi-state Research Projects and Activities to submit proposals and reports online. Interested parties, stakeholders and cooperators can also query the System for relevant and timely information. Future meeting authorization announcements will be made via this system.

- Annual reports are due with 60 days of annual meetings. In reports, Directors are looking for the integration of research and extension, multi-agency activity, and impacts for the public.
- Three NC projects did not get renewed this year. Problems identified were lack of regular committee meetings, poor attendance, and groups that were more an aggregate of individuals, lacking coherence. Dr. Venette stressed the importance of encouraging members to stay through the full meeting, including the annual business meeting.
- Dr. Venette also noted that, while NC directors would like to see multiple people from an institution participating in individual committee meetings, experiment station directors will usually fund one participant per committee.
- The ESCOP (Experiment Station Committee on Organization and Policy) publication A Science Roadmap for Agriculture may now be accessed from ESCOP's home page <a href="http://www.escop.msstate.edu/draftdoc.htm">http://www.escop.msstate.edu/draftdoc.htm</a>. The document identifies a set of agricultural research challenges and estimates future funding needs to address these challenges. Dr. Venette that agricultural research budget discussions for 2004 are already beginning.

## **Next Meeting Information**

#### **Location and Date**

The 2003 meeting will be held in or around Rutgers University (New Brunswick, NJ) in late February (or possibly early March) with the timing to avoid conflicts with other regional research meetings such as SERA-IEG-31"Economics and Management of Risk in Agriculture and Natural Resources."

#### **Meeting Program**

It was noted that ERS economists had suggested organizing the 2003 workshop around the theme of patents, including patenting by the private sector, universities and ARS. Several people noted that workshops worked better if they combined a theme topic with other work of NC-1003 members, not necessarily related narrowly to a single subject. Further discussion followed about expanding the theme of patents to include

- patents and public-private collaborative relationships
- privatization of public research
- implications of patenting and intellectual property rights for developing countries
- implications of patenting and intellectual property rights for the CGIAR system

There was also general discussion of inviting speakers from outside NC-1003. Possibilities included:

- Peter Day, Rutgers University
- staff from the Rockefeller Foundation
- IPR lawvers
- staff of university intellectual property offices
- staff of the ISAAA
- Richard Nelson, Columbia University

There was also discussion of combining the workshop with a tour of biotechnology labs or institutions near Rutgers.

## **Responsible Individual(s)**

Carl Pray (Rutgers) offered to serve as program planning committee chair and Brian Wright (UC-Berkeley) offered to serve on the planning committee. Given ERS's stated interested in organizing some presentations around issues of patenting, it was suggested that Paul Heisey (ERS) also be asked to serve on the planning committee. It was also suggested that Phil Pardey (Minnesota / IFPRI) serve. Heisey and Pardey were not present at the 2002 business meeting and will need to be contacted.

## **State Reports**

Arizona, California (Berkeley) Idaho, Iowa State, Michigan State, Montana State, New Jersey (Rutgers), Cornell (New York), Virginia Tech, and Wisconsin made reports. Activities discussed in State Reports are summarized in detail in the 2000 Annual Report.
