- a. Renewal update Nathan Smith, Chair

Show that there has been some evolution in the group. Show that there is a research component. Identify gaps in public policy research and education. Budget looks better this year. Omnibus spending bill was passed and the land grant experiment stations, AFRI, Hatch Act, Smith-Lever Funds all had some funding replenished to FY2012 levels with some added budget to some programs such as AFRI.
 - iii. Comment from Sanders: SERA39 did not formally get brought into SAEA/SAAS in the past, but it would be good to become a formal part

of it and have the official call for papers similar to SAEA rather than short notice before the SERA Annual meeting.

- c. National Farm Bill Education Training
 - iv. Nathan gave a brief overview of plans for Farm Bill education training.
 - v. Brad added that this is a cooperation of SERA39 and the Risk Management Education Centers and the Regional Farm Management Committees. Instead of putting together one National Train the Trainer conference, the plan is to utilize web technology to deliver content, mechanics and basic information quickly and affordably. The webinar series should roll out pretty quickly to be timely and relevant. We need to get everyone on board to participate. We can do a 2-day conference later as rules are finalized and decisions/impacts for farmers can be discussed. Can also team together to write a national set of fact sheets on this or regional specific fact sheets.
