Reports

Entrepreneurship and Business

The Entrepreneurship and Business group gave a report on activities related to the programs for 4-groups. Gerardo Martinez gave out a handout on the Hispanic Economic Development Corporation (HEDC). A similar program is currently underway in Saint Louis. HEDC created 12 new businesses in Kansas City MO. Ness talked some opportunities with the other Hispanic Chamber of Commerce in the U.S. (e.g., Dallas).

Families and Education

Member of The Families and Education committee were not able to attend. They did send an email on some activities which were a continuation of the activities from last. The co-chairs informed the group that they want to resign as chairs due to other activities. Members agreed and accepted the request and asked people to consider the opportunity to be chair and co-chair.

Building Immigrant-Friendly Communities

Gerardo Martinez talked about his work in Kanas City. In September his group launched a big campaign to reach out to Latinos. They conducted open dialogues with police chiefs, lawyers, and families to reduce fear in Latino families in Branson, Monat, Springfield, etc. regarding potential changes in how law enforcement treat immigrants. They reported that they reached out to Missouri Catholic Dioceses. They are working with law firm that wants to collaborate with Alianzas.

Building Diversity-Competent Organizations

The Building Diversity-Competent Organizations committee reported on several project:

Latinos farmers project – building Latino farmer competency. Researchers designed their own program based on JUNTOS – Exitos de Educative is the name of the program. This program may be used for other communities. Ruben Martinez gave an updated on the survey that was done in collaboration with Chuck. The report is now online with over 700 respondents that completed the survey

Demographics and Change

The Demographics and Change committee reported several activities: (1) Mapping Immigrant Populations workshop, (2) Mosaic Project, and (3) Hispanic Chamber of Commerce. The workshops focused on communities of high need and points of social determination. The chair of the group received a grant to study immigrant occupations to determine if they are using their credentials in their current jobs. A final report will be published in fall 2017.
