Wednesday, June 7

Welcome and Introductions:

Chair Sepúlveda convened the meeting at 8:39 a.m. The group thanked Kevin Armbrust for hosting the meeting. Host Armbrust welcomed everyone to Louisiana State University. Administrative Advisor Pritsos addressed the group about Hatch funding and trends in federal budget requests.

Report Reviews:

Seven reports were reviewed (Li, Armbrust, Jenkins, Gan, Peterson, Sepúlveda, Miller)

Robert Twilley, Director of the Louisiana Sea Grant, gave a discussion on the Sea Grant system, which is similar to the Land Grant system. He also spoke about the threat to deltas, land loss, land gain, ecosystem management, novel ecosystems, and ecosystem design.

We briefly discussed possible meeting locations for 2018. Possible locations included: Riverside, Minneapolis, Lincoln. It was decided to finalize our decision the next day, June 8.

B. Rogers Leonard, Associate Vice President, LSU Ag Center, discussed the LSU system with respect to agriculture. The Center consists of 14 academic units, 1,300 undergrads, 250 grads, 17 research stations. Particular strengths of the Center include plant breeding, sweet potato, sugar cane, aquaculture, rice, nutrient management, animal health, food incubator, and forestry.

Armbrust and Pritsos will encourage USDA-ARS directors to send their people to meetings. We also discussed possibly inviting industry folks to our meetings as *ex officio* members.

We decided the location of 2018 meeting will be Riverside, California. Dates TBD. The Chair for the 2018 meeting will be Kevin Armbrust; the Secretary will be Jeff Jenkins.
