Brief Summary of Minutes:

- 1) Review of participant activities and sharing of information: This included an update on newly funded projects of interest to Agriculture of the Middle, which included new research on grazing, hazelnuts, rural wealth creation, value-added retail, and hard cider market opportunities for orchardists.
- 2) Project reports:
- Discussion of new Local Food Marketing Practices survey, particularly in shaping questions for the survey, as well as an update on new the implementation process of new Farm Bill programs. (*Objective 1: Economics*)
- Discussion of Colorado State researchers using ARMS data to disaggregate market channels
 and to understand farmer performance matched with state level policy variables. Interested in
 understanding impacts by scale and commodity. (Objective 1 and 5: Economics, Policy)
- Discussion revolving around conceptualizing regional food systems, the role of values-based value chains, and the difficulty of transforming locally based network connections to regionally-based systems. (*Objective 2: Community Goals & Needs*)
- Wisconsin researchers discussed domestic fair trade research and potential impacts, especially around worker vulnerabilities and strategies. (Objective 2: Community Goals & Needs)
- Discussion of competition issues surrounding AOTM, including market access for small growers, as well as understanding how values shape both supply and demand curves, and how expectations of fairness can shape producer participation and influence competition policy. (Objective 4 and 5 Governance and Policy)

Accomplishments:

Objective 1: Investigate key factors that influence economic performance and viability of midscale farms/ranches and their supply-chain partners.

Objective 2: Identify and assess the possibilities of mid-scale supply chains to contribute to community goals and needs.

<u>California</u>: The UC Davis team continued to work in four main areas of research and outreach that addressed Objectives 1 and 2. They include: (1) farm to school/ farm to institution evaluation and food service procurement from regional producers; (2) new market development and training for small, mid-scale, beginning and immigrant producers through values-based supply chains; (3) agritourism as a strategy for small and midscale farmers to add value to their operations; and (4) contributions of food policy councils to local food policy, including that which impacts small and midscale farmers. Multiple projects allowed examination of perspectives and practices through the supply chain to understand challenges of farmers, distributors, processors, manufacturers, wholesalers, retailers and consumers who participate in these values-based supply chains.

- Farm to school/institution. Completed our farm to school evaluation work in Calaveras County. Held a Food Summit in June, 2019 with UC and CSU food service directors and food hubs, to explore constraints and opportunities for food hubs to sell more regional food to University/College food service.
- New market development/training for small and midscale farmers. Provided training and professional development for farmers and ranchers and our UCCE colleagues; held 1 famer-specialty food buyer mixer to introduce farmers and buyers in Northern CA to

each other; shared the 5 fact sheets (previous outputs from NC1198) for producers interested in working with the specialty food industry; conducted 8 farmer to farmer (CRAFT) tours in Northern CA for more experienced farmers to share practical information with beginning farmers; organized 2 on-farm food safety workshops for farmers who are part of food hubs; organized 1 farmer tour to wholesale buyers in the Sacramento area; organized 3 meetings (Dec, Mar & Sept) of the Farmer Educator Network to share needs and opportunities among organizations serving small and midscale and beginning farmers; organized a food hub convening as part of the Food Summit, bringing food service staff at the UCs and CSUs together with food hubs; organized one field day to learn about how to grow and market elderberries that are part of hedgerows on farms.

- Agritourism. Conducted 6 agritourism planning classes for farmers and ranchers (3 in Santa Cruz and 3 in Calaveras County) as part of the "Agritourism Intensive" workshop series. Provided at least 4 presentations for various organizations interested in agritourism.
- *Food policy councils*. One member of the food policy council research group organized one Bay Area food systems meeting at the Elkus Ranch to share current projects, including results of the food policy council research project.

Colorado: Colorado State University team evaluated how farm to school programs impact the economic performance and viability of mid-scale farms/ranches and the role of mid-scale value chains in supporting these markets. Given that approximately 42% of school districts nationally participate in farm to school, and that public dollars at both the federal and state levels are increasingly leveraged to both improve small and mid-scale farm access to markets and increase healthy eating outcomes in kids, evaluating these efforts is very important. Preliminary results show that farm to school purchasing does help some improve profitability outcomes for some mid-scale farms and ranchers. No observable evidence that kids are more likely to consumer fruits and vegetables that are identified as local, but found important spillover impacts in terms of household's additional purchases of fruits and vegetables in grocery stores in areas that have had farm to school programs for longer periods of time.

<u>Wisconsin</u>: University of Wisconsin wrapped up the AFRI "Understanding Domestic Fair Trade for Agriculture of the Middle" project. We reviewed three conceptual frameworks for domestic fair trade. An economic analysis of farm labor wages and earnings outcomes compared to other low-skill employment used data from USDAs Farm Labor Survey, The Department of Labor's NAWS, US Census Bureau's ACS. Six cases relevant to domestic fair trade were researched and synthesized. The team developed a Workers Rights Card in English and Spanish, available on the project web site at http://cias.wisc.edu/fair-trade/. <u>Cider Project:</u> Team members from UVM, UW-Madison, MSU, and WSU wrote and obtained a USDA NIFA AFRI Small and Mid-Sized Farm Prosperity grant (USDA AFRI #2018-68006-28105) to implement a survey of cider apple growers that addresses the economic performance, the environmental and natural resource aspects, and the community benefits of supply chains for craft hard cider production. Survey invitations were sent via Qualtrics to a list of 82 cider apple growers compiled through Cider Association and Extension records from each of the four states involved in the project (WA, WI, MI, and VT). The project has been advised by a national stakeholder advisory committee and results will be analyzed and shared in the upcoming year.

Objective 4: Examine and assess governance structures and mechanisms of mid-scale supply chains and their role in mediating, communicating, and implementing values around food quality, economic performance, social equity, and environmental sustainability.

<u>Colorado</u>: Colorado State University team has examined how urban food policies support farmers, ranchers, and rural communities, paying particular attending to how these policies impact mid-scale operations. Through the research is still on-going, substantial progress has been made on the Extension side, bringing mid-scale operations into direct conversations with urban buyers and policy makers. We hope that this will help to expand market opportunities, as well as urban understanding of potential impacts of proposed policies.

Objective 5: Build the capacity of project members to investigate, address, and communicate policy issues surrounding mid-scale supply chains.

Kate Clancy and Kathy Ruhf are synthesizing journal articles, book chapters, websites and other resources in developing a report on regional food systems.

Wisconsin: Lindsey Day Farnsworth and Michelle Miller worked with the City of Madison to secure funding for a business plan for a public food terminal that would serve small and mid-size farmers. The City kicked in \$135,000 for the work that began in earnest this spring. Governance structures are a core part of this work. Farnsworth is completing work on terminal market structure and governance. CIAS is partnered with farm and food businesses on a grant from the Local Food Promotion Program (USDA-AMS), now in its second year
