W4185 Administrative Meeting. Steve Novak (Meeting Organizer and past Chair), Ruth Hufbauer (Chair), Sanford Eigenbrode, Adviser.

- 1. **Status of project**. After opening welcome statements by both Steve Novak and Adviser, Sanford Eigenbrode, a summary of the status of the Renewal submission was presented. The Renewal (now document W-5185 Temp) was submitted in January and is currently out for external review. Once those are in, comments will be distributed for our response. Before the Renewal was submitted, everyone was contacted and encouraged to resubmit their Appendix E should they wish to be a member of the next project cycle. In the past, the project would be approved and then a call would be distributed for those interested in participating. Thanks were extended to all the members that became part of the "renewal team".
- 2. Nominations and election of new Secretary and Member-at-Large. We will be emailing the group in the coming few months to get nominations for the next Secretary and Member-at-Large. We do have a few names but would like to add to the list. These officers will be responsible for meetings in the next 2 years. Ruth Hufbauer (CO State), our current Secretary, sent information to Steve Novak to assist the discussion about the next meeting location and dates (below).
- 3. **Annual/Termination report** individual reports due date and Termination report completion. The deadline for Annual Reports is 90 days after the official Annual meeting, so a deadline for individual reports will be June, 1, 2022.
- 4. **Location of next meeting** and discussion about past and future venues (issue of co-locating or continuing a stand-alone meeting). Ruth Hufbauer relayed the results of the survey she conducted earlier in the year concerning how and when we should meet next. Results showed the group wished to continue with stand-alone meetings in the fall vs. co-locating with another group. Simply holding a symposium limits the interaction a group of our size and diversity requires. Our normal 2 day meeting allows for members who travel farther distances to justify a comprehensive experience. Ruth is suggesting a repeat trip (last held in 2011) to the YMCA of the Rockies near Estes Park, CO, for October of this year (the next fiscal year). This puts us back on schedule after Covid-19 disrupted our meetings for the past 2 years. We will send details within a month for more input and to get rates and availability.
