Greetings:

We are glad to inform you all that we are looking forward to a great program this year in Albany, California. Here are some of the details regarding the meeting this year. We will be sending you updates in coming weeks and hope we have a great participation.

1. **Date and Time:** The 2016 S-1041 multistate committee meeting will be held on 8 and 9th August, 2106 at Western Regional Research Center, Albany, California.
2. **Student poster competition:** We will have a student poster presentation competition and recognize three best posters. All students who wish to participate in poster competition must submit a letter from their advisor indicating their current student status (no exceptions to this requirement).
3. **Registration fees:** A registration fee of \$100 for all participating members payable by cheque. Registration will include lunch and tea/coffee for the two days of the conference and publication costs. All registrants will be provided with a copy of the proceedings. We are setting up an account with Oregon State University to handle all the expenses related to this conference. We will update you in the next email with details of the account to which your registration fee cheques must be made.
4. **Symposium:** As we all discussed last year, we will be having a symposium on “Food, Energy and Water Nexus”. The organizing committee has been working very hard and we have a great lineup of speakers from producers, industry and policy makers.

COPRODUCTS FROM CORN PROCESSING: ENERGY, NUTRIENTS AND WATER

Coproducts, including fuel ethanol and a range of biobased products, are produced in parallel with a primary product during processing. One fourth to one third of material exiting modern corn processes does not increase in value relative to original corn value (Rausch and Belyea, 2006).

The enzymatic dry grind process creates a germ coproduct with oil content similar to germ from wet milling wet milling and a distillers dried grains with solubles (DDGS) coproduct with reduced fiber and increased protein contents (Singh et al., 2005).
